Code of Conduct

Mandatory - Quality Area 4

PURPOSE

This policy provides guidelines to enable Somerville Kindergarten Incorporated to establish the expected standards of behaviour for the Approved Provider, Nominated Supervisor, staff, contractors, volunteers, students on placement, parents/guardians and visitors. Create and maintain a child safe environment that reflects the philosophy, beliefs, objectives and values of Somerville Kindergarten. Always promote desirable and appropriate behaviour, and promote interactions at the service which are respectful, honest, courteous, sensitive, tactful and considerate.

VALUES

Somerville Kindergarten is committed to the safety, health, and well-being of the children at our kindergarten. All policies and procedures safeguard the safe delivery and collection of children being educated and cared for at the kindergarten. Service leaders, ECT's, educators, and staff are provided with the necessary training and support to implement the policies and procedures for the delivery of children to, and collection from the kindergarten premises.

SCOPE

This policy applies to the Approved Provider, Persons with Management or Control, Nominated Supervisor, Person in Day to Day Charge, staff, contractors, volunteers, students on placement, parents/guardians and visitors attending the programs and activities of Somerville Kindergarten.

IMPLEMENTATION

The child may only leave the service in the care of a parent/guardian, authorised nominee, or a person authorised by one of these parties to collect the child. An authorised person does not include a parent who is prohibited by court order from having contact with the child.

Approved Provider or Persons with Management and Control Is responsible for:

- providing a safe environment for staff, contractors, volunteers, students on placement, parents/guardians, children and others attending the programs and activities of Somerville Kindergarten
- providing guidance through leadership and by being a positive role model developing and updating/ reviewing codes of conduct for Somerville Kindergarten in collaboration with the Nominated Supervisor, staff, parents/guardians, children and others involved with the service
- ensuring that staff, volunteers, students and parents/guardians are provided with a copy of this policy on employment, engagement or enrolment at the service and that the current codes of conduct are publicly displayed and promoted to everyone including contractors and visitors
- ensuring that staff complete and sign the *Code of Conduct Acknowledgement* and that these are filed with individual staff records upon engagement in the service
- ensuring that the codes of conduct are regularly discussed at staff meetings to reinforce expectations
- developing a culture of accountability within the service for complying with the code(s) of conduct and being prepared to respond when behavioural expectations are not adhered to
- ensuring that all children being educated and cared for at Somerville Kindergarten are protected from harm and any hazard likely to cause injury (National Law: Section 167) and that the children know who to speak to about any concerns and that their concerns are followed-up
- working with the Nominated Supervisor, staff, students, volunteers, parents/guardians and others at the service to provide an environment that encourages positive interactions, supports constructive feedback and holds one another to the codes of conduct
- ensuring that parents/guardians of a child attending the service can enter the service premises at any time that the child is being educated and cared for, except where this may pose a risk to the safety of children or staff, or conflict with any duty of care of the Approved Provider, Nominated Supervisor or educators under the Law
- ensuring that contractors, volunteers, parent/guardians, students or visitors at the service are not placed in a situation where they are left alone with a child

- respecting individual abilities, needs, cultural practices and beliefs in all interactions, both verbal and non-verbal
- notifying DET in writing within 24 hours of a serious incident or of a notifiable complaint at the service (National Law: Sections 174(2)(b) and 174(4), National Regulations: Regulations 175(2)(c) and 176(2)(b)) via the NQAITS
- referring notifiable complaints, grievances or complaints that are unable to be resolved appropriately and in a timely manner to the Grievances Subcommittee/investigator
- activating the *Complaints and Grievances Policy* on notification of a breach of the *Code of Conduct Policy*
- taking appropriate disciplinary or legal action, or reviewing the terms of employment in the event of misconduct or a serious breach of the *Code of Conduct Policy*
- contacting Police in an emergency situation where it is believed that there is an immediate risk, such as when violence has been threatened or perpetrated or where sexual abuse or grooming is suspected as outlined in the *Child Safe Policy*.

Management /Nominated supervisor / Responsible person will:

- ensure that the children educated and cared for at Somerville Kindergarten are protected from harm and from any hazard likely to cause injury
- provide guidance through their leadership and by being a positive role model
- assist the Approved Provider to develop codes of conduct for staff and parents/guardians, students, contractors, volunteers and visitors
- o complete and signing the Code of Conduct Policy Acknowledgement for staff
- o adhere to the Code of Conduct for staff at all times
- inform the Approved Provider in the event of a serious incident of a notifiable complaint or of a breach of the *Code of Conduct Policy*
- contact Police in an emergency situation where it is believed that there is an immediate risk, such as when violence has been threatened or perpetrated, or where sexual abuse or grooming is suspected as outlined in the *Child Safe (formerly Child Protection) Policy*
- work with the Approved Provider, staff, students, volunteers, parents/guardians and others at the service to provide an environment that encourages positive interactions, supports constructive feedback and holds one another to the codes of conduct
- ensure that parents/guardians, students and volunteers sign the code of conduct
- ensure that parents/guardians of a child attending the service can enter the service premises at any time that the child is being educated and cared for, except where this may pose a risk to the safety of children or staff, or conflict with any duty of care of the Approved Provider, Nominated Supervisor or educators under the Law
- develop practices and procedures to ensure that parent/guardians, students, contractors, volunteers or visitors at the service, are not placed in a situation where they are left alone with a child
- respect individual abilities, needs, cultural practices and beliefs in all interactions, both verbal and non-verbal
- understand and accepting that serious breaches of this code will be deemed misconduct and may lead to disciplinary or legal action, or a review of their employment.

Educators will:

- assist the Approved Provider to develop a code of conduct for staff (refer to Attachment 1) completing and signing the *Code of Conduct Policy Acknowledgement* adhering to the code of conduct for staff at all times
- provide guidance to students, volunteers, parents/guardians, students and visitors through positive role modelling and, when appropriate, clear and respectful directions
- work with the Approved Provider, Nominated Supervisor, their colleagues, students, volunteers, parents/guardians and others at the service to provide an environment that encourages positive interactions, supports constructive feedback and holds one another to the codes of conduct
- ensure that parents/guardians, students, contractors, volunteers and visitors at the service are not placed in a situation where they are left alone with a child
- inform the Approved Provider in the event of a serious incident, of a notifiable complaint or of a breach of the *Code of Conduct Policy*
- contact Police in an emergency situation where it is believed that there is an immediate risk, such as when violence has been threatened or perpetrated or where sexual abuse or grooming is suspected as outlined in the *Child Safe (formerly Child Protection) Policy*.

- respect individual abilities, needs, cultural practices and beliefs in all interactions, both verbal and non-verbal
- understand and accept that serious breaches of this code will be deemed misconduct and may lead to disciplinary or legal action, or a review of their employment.

Families will:

- read the Code of Conduct Policy
- complete and signing the Code of Conduct for parents/guardians
- abide by the Code of Conduct for parents/guardians
- comply with all policies of the service.

All Volunteers and students, whilst at Somerville Kindergarten, are responsible for following this policy and its procedures. Staff to always make sure that they are aware of all policies and procedures before commencing.

BACKGROUND

Codes of conduct establish standards of behaviour to be followed and define how individuals are expected to behave towards each other, towards the children in their care, and towards other organisations and individuals in the community.

The Approved Provider, Nominated Supervisor and staff have a duty of care to the children attending the service and must ensure 'that every reasonable precaution is taken to protect children being educated and cared for by the service from harm and from any hazard likely to cause injury' (National Law: Section 167).

The *National Quality Standard* requires that staff are respectful and ethical and that 'professional standards guide practice, interactions and relationships' (*National Quality Standard*: 4.2 and 4.2.2).

Employers also have a legal responsibility to provide, as far as is practicable, a safe workplace that is free from discrimination, bullying and harassment.

Child Safe Standard 3 requires services to develop and review codes of conduct that establish clear expectations for appropriate behaviour with children including:

- o how to respond to risks adults may pose to children or that children may pose to each other
- how to ensure the cultural safety of Aboriginal children and culturally and linguistically diverse children
- how to be inclusive of all children, including children with a disability.
- A Code of Conduct should be informed by the service's philosophy, beliefs and values, and based on ethical principles of mutual respect, equity and fairness. Consideration should be given to the Victorian Teaching Profession *Code of Conduct and the Code of Ethics* and to the Early Childhood Australia's *Code of Ethics* in developing the Code of Conduct.

The Approved Provider must ensure that the Nominated Supervisor, staff, contractors, volunteers, students on placement, parents/guardians, children and others attending the programs and activities of Somerville Kindergarten adhere to the expectations outlined in the Code of Conduct when communicating to and interacting with:

- o children at the service and their parents and family members
- \circ each other
- others in the community.

EVALUATION

In order to assess whether the values and purposes of the policy have been achieved, the Approved Provider will:

- \circ regularly seek feedback from everyone affected by the policy regarding its effectiveness
- \circ monitor the implementation, compliance, complaints and incidents in relation to this policy
- $\circ\;$ assess whether a satisfactory resolution has been achieved in relation to issues arising from this policy
- \circ keep the policy up to date with current legislation, research, policy and best practice
- \circ revise the policy and procedures as part of the service's policy review cycle, or as required
- o notify parents/guardians at least 14 days before making any changes to this policy or its procedures.

DEFINITIONS

Bullying: Repeated verbal, physical, social or psychological behaviour that is harmful and involves the misuse of power by an individual or group towards one or more persons. Bullying occurs when one or more people deliberately and repeatedly upset or hurt another person, damage their property, reputation or social acceptance.

Duty of care: A common law concept that refers to the responsibilities of organisations to provide people with an adequate level of protection against harm and all reasonable foreseeable risk of injury.

Harassment: When someone is demeaning, derogatory or intimidating towards another person. Harassment includes:

- \circ racial taunts
- o taunts about sexual orientation or gender identity
- o sexual harassment: unwelcome physical, verbal or written behaviour of a sexual nature
- o repeated insulting remarks.

Notifiable complaint: A complaint that alleges a breach of the Education and Care Services National Act or Regulation, or alleges that the health, safety or wellbeing of a child at the service may have been compromised. Any complaint of this nature must be reported by the Approved Provider to the secretary of DET within 24 hours of the complaint being made (Section 174(2) (b), Regulation 176(2) (b)). Written reports to DET must include:

- o details of the event or incident
- \circ the name of the person who initially made the complaint
- if appropriate, the name of the child concerned and the condition of the child, including a medical or incident report (where relevant)
- o contact details of a nominated member of the Grievances Subcommittee/investigator
- Any other relevant information.

Written notification of complaints must be submitted via the National Quality Agenda IT system (NQAITS): <u>http://www.acecqa.gov.au/national-quality-agenda-it-system.</u> If the Approved Provider is unsure whether the matter is a notifiable complaint, it is good practice to contact DET for confirmation.

Respect: Demonstrating regard for the rights of individuals, for different values and points of views.

Serious incident: A serious incident is defined as (regulation 12):

 \circ the death of a child -

- while being cared for by an education and care service; or
- following an incident while being educated and cared for by an education and care service

- $\circ~$ any incident involving serious injury or trauma to, or illness of, a child while being educated and cared for by an education and care service -
 - which a reasonable person would consider required urgent medical attention from a registered medical practitioner (examples include broken limbs or anaphylaxis reaction) attention of a registered medical practitioner; or
 - for which the child attended, or ought reasonably to have attended a hospital.
- $\circ~$ any incident where the attendance by emergency services at the education and care service premises was sought, or ought reasonably to have been sought
- any circumstances where a child being educated and cared for by an education and care service appears to be missing or cannot be accounted for;
 - appears to have been taken or removed from the education and care services premises in a manner that contravenes National Regulations;
 - is mistakenly locked in or locked out of the education and care service premises or any part of the premises.

The Regulatory Authority must be notified of a serious incident (section 174(2)(a)) in writing in the case of:

- $\circ\;$ the death of a child, as soon as practicable but within 24 hours of the death, or the time that the person becomes aware of the death
- $\circ\;$ any other serious incident, within 24 hours of the incident or the time that the person becomes aware of the incident

Written notification of serious incidents must be submitted via the ACECQA portal using the appropriate forms at <u>https://www.acecqa.gov.au/resources/applications</u>. Support: Work in a co-operative and positive manner.

ATTACHMENT 1: CODE OF CONDUCT FOR THE APPROVED PROVIDER, PERSONS WITH MANAGEMENT AND CONTROL, NOMINATED SUPERVISOR AND ALL STAFF

The Approved Provider, Persons with Management and Control, Nominated Supervisor and all staff at Somerville Kindergarten are responsible for promoting the safety and wellbeing of children and their families by:

- o welcoming all children and their families and being inclusive
- o treating everyone with respect, including listening to and valuing their ideas and opinions
- o contributing to a culture of child safety
- o adhering to the Child Safe (formerly Child Protection) Policy and all other policies
- o taking all reasonable steps to protect children from abuse
- o respecting the privacy of children and their families, and only disclosing information to people who have a need to know as required under the *Privacy and Confidentiality Policy*
- o reporting and acting on any breaches of this Code of Conduct, complaints or concerns.

Professional Responsibilities

The Approved Provider, Persons with Management and Control, Nominated Supervisor and all staff demonstrate our commitment to our professional responsibilities by:

undertaking duties in a competent, timely and responsible way

- o ensuring our knowledge and expertise is up to date and relevant to our roles
- o being aware of the role of other professionals and agencies and working collaboratively and within the limits of our professional expertise
- o understanding and complying with legal obligations in relation to:
 - discrimination, harassment and vilification
 - negligence
 - grooming
 - disclosure of child sexual abuse
 - protection of a child from child sexual abuse
 - mandatory reporting
 - privacy and confidentiality
 - occupational health and safety, including emergency evaluation procedures
 - raising any complaints or grievances in accordance with the Complaints and Grievances Policy
 - maintaining teacher registration and Working with Children checks as applicable.

Relationships with Children

The Approved Provider, Persons with Management and Control, Nominated Supervisor and all staff at Somerville Kindergarten demonstrate our commitment to high-quality education and care for children by:

- $\circ~$ encouraging children to express themselves and their opinions
- \circ allowing children to undertake experiences that develop self-reliance and self-esteem
- \circ $\,$ maintaining a safe environment for children $\,$
- $\circ~$ being a positive role model at all times
- $\circ~$ speaking to children in an encouraging and positive manner ~
- o giving each child positive guidance and encouraging appropriate behaviour
- providing opportunities for children to interact and develop respectful and positive relationships with each other, and with other staff members and volunteers at the service

- $\circ\;$ regarding all children equally, and with respect and dignity
- $\circ\;$ having regard to their cultural values and supporting them to express their culture
- respecting individual difference including age, physical and intellectual development, and catering for the abilities of each child at the service
- $\circ~$ working with children in an open and transparent way by informing other staff about the work being done with children
- \circ encouraging and assisting children to undertake activities of a personal nature for themselves e.g. toileting and changing clothes
- informing children if physical contact is required for any purpose, asking them if they are comfortable with this interaction and complying with the *Interactions with Children policy*.

Relationships with parents/guardians and families

In our relationships with parents/guardians and families, the Approved Provider, Nominated Supervisor and all staff demonstrate our commitment to collaboration by:

- \circ working collaboratively with parents/guardians and families
- considering the perspective of parents/guardians and families when making decisions that impact on the education and care of their child
- o communicating with parents/guardians and families in a timely and sensitive manner
- o responding to concerns expressed by parents/guardians and families in a timely and appropriate manner.

Relationships with employer and between colleagues

In relationships with the Approved Provider, Persons with Management and Control, Nominated Supervisor and between colleagues, staff demonstrate collegiality by:

- $\circ~$ encouraging others to act in accordance with this Code of Conduct and taking action when they observe behaviours which are outside of the Code of Conduct
- \circ developing relationships based on mutual respect, equity and fairness
- $\circ\;$ working in partnership in a courteous, respectful and encouraging manner
- \circ valuing the input of others
- \circ sharing expertise and knowledge in appropriate forums, and in a considered manner
- o respecting the rights of others as individuals
- \circ giving encouraging and constructive feedback, and respecting the value of different professional approaches
- $\circ~$ being prepared to have difficult conversations and use constructive processes to address differences of opinion.
